If NAfME approves your blog post, we will credit you for your work, and will publicize your work on our website, one or more of NAfME's social media pages, and/or in our newsletter to all current members of NAfME on a timeline to be determined by NAfME.

#### Please consider these recommendations when writing your blog post:

- 800 2,500 word article. Please submit as a Word or Google document.
- Additional formatting options include Q&A, infographic, charts, top 10 lists, sample handouts, video examples.
- Begin with a catchy opening line or question to draw in your reader.
- Consider breaking up your content into sections using subheadings.
- Use short paragraphs, bullet points, quotes, lists, bolds and italics to help make your post easy to read and digest.
- Include supporting images and/or video where applicable.
- Provide supporting resources for readers (please include hyperlinks and cite sources)
- Include all references.

# Please provide the following along with your post:

### 1. A professional description of yourself

- Length: 100-150 words
- Start with your current job title and school/organization affiliation. Include city and state.
- Prioritize key information. If bios need to be shortened, they will be condensed from the bottom.
- **2. Headshot** (jpg or png file type)
