III Call to Order

President Scott R. Sheehan called the meeting to order at 7:09 p.m. Eastern Time on Monday, November 28, 2022.

IV Review and Adoption of Agenda (Appendix A)

IT WAS MOVED BY WILLIAMS, SECONDED BY HAMMEL, AND CARRIED UNANIMOUSLY TO ADOPT THE AGENDA, INCLUDING THE CONSENT AGENDA, WITH FLEXIBILITY AS DIRECTED BY THE PRESIDENT:

V Reports/Ongoing Business

A Report of Chair, Executive Committee

President Sheehan asked Chief Financial and Administrative Officer Chaudlier Moore to provide an overview of the finances. Mr. Moore noted the board was receiving financial reports for the months of September 2022 and October 2022. Mr. Moore informed the board the September 2022 financial report was a supplemental report to what had previously been shared with the board. Due to competing commitments (higher than expected join/renew membership numbers, and an active NAfME audit) the quarterly reconciliation was delayed several weeks. The completed quarterly reconciliation resulted in the recognition and posting of additional revenue.

Mr. Moore reviewed the October 2022 month to date (MTD) and year to date (YTD) expenses, revenue, and investments. Mr. Moore was asked where the 2022 National Conference revenue was reflected and informed the board that those conference funds would be reflected now that the event had occurred. This is an accounting best practice recommended by the NAfME Auditors.

President Sheehan updated the board on the Audit Committee appointments. President Sheehan and Executive Director Chris Woodside have conducted outreach to individuals to request their service on the NAfME Audit Committee. Responses have not yet been received by all who were asked. Once individuals have agreed to serve, the board will be asked to vote on those appointments. The board will be kept apprised of that progress.

President Sheehan asked AED Amanda Karhuse to provide the board with an Advocacy and Public Policy update. Work continues on expanding the Music Education Policy Roundtable and bringing new voices to the table. The Advocacy and Public Policy team also supports state MEAs in crafting their advocacy plans and building campaigns and is planning the association's activities to commemorate Music In Our Schools Month in March. Hill Day 2023 planning will increase at the beginning of the New Year leading up to National Assembly 2023.

President Sheehan asked Eastern Division President Sue Barre to provide the board with an update on the 2027 Eastern Division Conference Proposal. Eastern Division President Barre reviewed the report from the Eastern Division Board that recommended the conference be held in Rhode Island. Next steps include Rhode Island MEA beginning to work with the Office of the Executive Director to follow policy guidelines for the planning of the 2027 Eastern Division Conference.

IT WAS MOVED BY SALVADOR, SECONDED BY HAMMEL, AND CARRIED UNANIMOUSLY TO APPROVE THE 2027 EASTERN DIVISION CONFERENCE PROPOSAL, AS PRESENTED.

President Sheehan asked Immediate Past President Mackie V. Spradley to provide an update from the Equity Committee. Immediate Past President Spradley noted the committee would begin their review of the candidates for the National Nominating Committee (NNC). This work will culminate in a recommendation to the National Executive Board of a slate of candidates to serve on the NNC for the 2024 National President-Elect election. Immediate Past President Spradley discussed with the board the ongoing work on the Strategic Plan through the Equity Committee, the Equity Leadership Institute (ELI), and the Strategic Plan Writing Teams. Next steps include beginning the process of the Implementation Planning to include these and additional groups. There will be a town hall and webinar meetings to kick start that planning.

President Sheehan asked North Central Division Immediate Past President Karen Salvador to report on the Division Concepts Laws paper that she is authoring. North Central Division Immediate Past President Salvador informed the board the paper was currently being reviewed by the NAfME Executive Committee and staff for feedback and formatting concerns. The board would continue to be updated on this topic.

President Sheehan asked Southwestern Division President-Elect and Professional Development and Partnerships Committee (PLPC) Chair-Elect Martha Gabel to update the board on the work of the committee. Chair-Elect Gabel informed the board of the many webinars planned to close out the calendar year, as well as a recent town hall hosted by the PLPC that included a rich dialogue on the topics of behavior management, partnering with principals and working to build advocacy in the school community. Staff will work with the PLPC on turning that dialogue into action. Chair-Elect Gabel noted for the board the PLPC was working with President Sheehan to finalize the TM Advisory Committee members and processes for reviewing content submissions sent to NAfME specific to the council area of expertise. The board will be kept informed on this topic.

President Sheehan requested President-Elect Deb Confredo provide a report of the Music Teacher Profession Initiative task force. President-Elect Confredo informed the board the task force was reviewing the data from interviews they conducted with schools and developing a code book with headings and subheadings to best capture the data. The task force plans to produce a white paper. Next steps include consideration of how to promote the white paper and create opportunities with webinars and other communication options.

President Sheehan reviewed for the board the NAfME National Nominating Committee timeline, as well as the January 2023 election timeline.

President Sheehan informed the board of an upcoming partnership with the National Association of Music Merchants (NAMM) that will include professional development opportunities for NAfME and NAMM members. The Guitar Council will be the lead volunteer group providing content for this professional development.

President Sheehan led dialogue about past and upcoming state visits to ensure all Division Presidents are aware of the rotation of visits for the 2 years of his presidency. The board agreed there should be touch points throughout the year with the state MEAs and to coordinate those efforts.
