V Reports/Ongoing Business

A Report of Chair, Executive Committee

Mr. Moore informed the board the Audit Committee met earlier in the week to discuss these items and provide a recommendation to the board. The Audit Committee recommended the board accept and file the audit and 990 tax documents. NAfME had a clean audit with no material misstatements.

President Confredo reviewed for the board the NAfME National Nominating Committee (NNC) timeline, as well as the January 2026 election timeline. President Confredo reminded the board that the "Call for Candidates" announcement had been extended in order to meet the minimum number of candidates per policy. To give the NNC a suitable amount of time to review and present a list of candidates to the board, there is a request to grant a variance to the timeline outlined in policy I.J.001.

It was moved by Fennell, seconded by Blackman, and carried unanimously, to approve a one-cycle variance to apply four (4) weeks to relevant deadlines in the I.J.001 Nominations President-Elect, National and Division policy. Board Member Adrian Davis was excused from the board meeting at 12:48 p.m. and invited to return at 12:56 p.m.
